ORDINANCE NO. 0621-01

AN ORDINANCE OF THE CITY OF LINDSAY, TEXAS, AMENDING THE FEE SCHEDULE BY AMENDING THE FEES FOR COMMERCIAL AND MULTI-FAMILY PLAN REVIEW AND INSPECTIONS; ACCESSORY BUILDING PERMIT FEES; CERTIFICATE OF OCCUPANCY FEES; **PRELIMINARY** PLATS; FINAL PLATS; COMBINATION PRELIMINARY AND FINAL PLATS; COMMERCIAL PRELIMINARY PLATS: **COMMERCIAL** FINAL PLATS; DEVELOPMENT PRELIMINARY PLATS; DEVELOPMENT FINAL PLATS; SIMPLE PLATS; PRELIMINARY PLAT APPLICATION ESCROW FEES; SEWER FEES FOR COMMERCIAL PROPERTY INSIDE THE CITY LIMITS; AND COMMERCIAL METER DEPOSIT INSIDE THE CITY LIMITS; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Lindsay, Texas, is a Type A general law municipality located in Cooke County, created in accordance with Chapter 6 of the Local Government Code, and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, the City Council has previously adopted fees for building permit fees, zoning and subdivision fees, water and sewer fees inside the City limits, and has codified such fees in a fee schedule; and

WHEREAS, the City Council now finds it necessary to amend the schedule of fees concerning building permit fees, zoning and subdivision fees, water and sewer fees inside the City limits.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LINDSAY, TEXAS:

SECTION 1.

- (a) The fees assessed by the City for building permit fees, zoning and subdivision fees, water and sewer fees inside the City limits, and other services that are offered to the public and to citizens of the City are hereby adopted as set forth on the City Fee Schedule attached hereto as Exhibit "A" and incorporated herein.
- (b) The City may amend the Fee Schedule to modify these fees or to add additional fees for other services from time to time as determined by the City Council.

SECTION 2.

This Ordinance shall be cumulative of all provisions of ordinances of the City of Lindsay, Texas, except where the provisions of this Ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

SECTION 3.

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this Ordinance are severable, and if any phrase, clause, sentence paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

SECTION 4.

This Ordinance shall be in full force and effect after its passage and publication.
