At 7:01PM the Mayor opened a public hearing to consider public comments on and consider the budget for the 2022-2023 fiscal year and set the 2022-2023 tax rate. The proposed M&O tax rate is 0.1927 per \$100 of value and the proposed I&S tax rate is 0.2402 per \$100 of value for a total proposed tax rate of 0.4329 per \$100 of value. The proposed tax rate would increase total taxes in the city of Lindsay by \$30872.00 or 5.7%; of that amount \$18,016.48 is tax revenue raised from new property added to the tax roll this year.

No one was present to speak so the Mayor closed the public hearing at 7:02PM.
