In making this application, I affirm that I have read and understand all provisions included within Ordinance 0120-2 (as codified in Chapter 72 of the Lindsay Code of Ordinances) and acknowledge that this permit may be revoked at any time by the City if I or any operator fails to abide by the established rules and regulations.

- (1) No person may stand or ride in the lap of the driver and/or other passenger of a golf cart while it is moving. No person younger than six (6) years of age may be transported in a golf cart unless restrained by a safety belt restraint.
- (2) Operators are not permitted to use the golf cart on any street that is designated as part of a State or Federal highway system, including but not limited to:
 - a. Highway 82.
 - b. Main Street.
 - c. Ash Street (*from Main St to Hwy 82*).
 - d. Hickory Street/Farm-to-Market 3108.
- (3) Operators must comply with all federal, state and local laws and ordinances
- (4) Operators are required to have a valid drivers license pursuant to Texas Transportation Code § 521.001(3) and 521.021, as amended.
- (5) Operators must maintain current financial responsibility for the golf cart, as required of other passenger vehicles in Section 601.051 of the Texas Transportation Code;
- (6) All equipment required for the issuance of this permit is installed and will be kept operational during the permit period.
- (7) I and any user shall indemnify and hold harmless the City of Lindsay, Texas for any and all civil liability associated with said registration waives any and all rights to sue or allow subrogation by insurance company.
